



Terms and Conditions- CAL Isuzu- Win a Chevrolet Silverado Promotion

- 1) Valid entries are only accepted for NEW Isuzu truck orders through any CAL Isuzu Sales Consultant, Fleet Salesperson, Or Sales Manager, ordered between 8:00am 01/12/2025 and 5:00pm 31/03/2026.
- 2) Entry is open to CAL Isuzu new Isuzu vehicle customers aged 18 or over except employees of the promoter Commercial Autos 2008 Limited ("CAL Isuzu"), their families, CAL Isuzu associated companies, agencies or anyone professionally connected with the promotion.
- 3) Entries will only remain valid if:
 - a) The eligible purchaser pays the final vehicle invoice in full by 31/03/2026.
 - b) The eligible purchaser does not cancel the eligible order at any stage.
- 4) Each eligible customer who meet the criteria described in these terms and conditions will automatically receive one entry into the promotion per eligible vehicle purchased.
- 5) The prize is for one 2025 Chevrolet Silverado 1500 LTZ Premium, including the vehicle itself and any standard on road costs. Any desired accessories or extra's will not be included in this promotion, the prize winner will need to contact their local GMSV dealer to have these fitted at the prize winner's cost. Any insurance, maintenance and associated running costs for the prize vehicle are at the prize winner's cost.
- 6) For ownership change, the winner must provide a valid New Zealand drivers license.
- 7) The prize draw will be drawn within 10 working days of the completion of the promotional period listed in 1). Prize winners will be notified by CAL Isuzu by phone and email. If a prize winner does not make contact with CAL Isuzu to claim their prize within 10 working days of initial notification, then CAL Isuzu may redraw the prize at its sole discretion from other eligible entries.

 - a) The entity that is paying the final invoice.
 - b) The entity listed on the "invoice to" section of the CAL Isuzu vehicle invoice.
